This year's conference, titled 'Digital Inclusion in the Information Society,' will be held both inperson and remotely, in collaboration with the European Accessibility Resource Centre -AccessibleEU. The conference will focus on various solutions, insights, and methods for digital inclusion. The experiences gained from the remote communication challenges during the COVID-19 pandemic have underscored the vital role of assistive technologies in ensuring that everyone can participate in social settings, education, and the workplace.

The **DIGIN 2024** conference is aimed at raising networking, awareness, studying, and presenting new ways of using supportive technologies to include all people with various forms of disabilities, which includes:

- Physically disabled people,
- Blind and visually impaired people,
- Deaf and hard of hearing people,
- People with cognitive functioning difficulties and also
- Older people with various forms of disabilities.

The conference will be held under the auspices of the multi-conference Information Society 2024 and will have a character of awareness-raising, informing, networking, and consulting.

This year's conference Digital Inclusion in the Information Society - DIGIN will take place at the Jožef Stefan Institute, Jamova 39, 1000 Ljubljana, Slovenia.

The conference is organized by the Jožef Stefan Institute, the University of Maribor, the Faculty of Electrical Engineering, Computer Science and Informatics, and the European Center AccessibleEU.

Author Guidelines

The program committee invites authors to contribute who can present new ideas and trends in the areas covered by the conference.

Both theoretically and empirically designed contributions are welcome, but they must always be framed within professional or scientific work.

The contribution should not exceed **four A4 pages** in principle. It can be written in Slovenian or English. An abstract is mandatory, and literature and other constituent parts must comply with the usual structure of articles presented at scientific conferences.

The format of the contribution is available in the document with templates for Word/Latex format: https://is.ijs.si/wp-content/uploads/2022/08/IS2022-template-1.zip. Authors should submit contributions with the title, email, and address of the corresponding person in the EasyChair system. The program committee will review and evaluate the contributions. Among the contributions, an **award for the best article** will be given. Several best articles will also go through a review process for the Uporabna informatika (Applied Informatics Journal) and the scientific journal Informatica.

Conference Program

Presentations will be organized in sections according to the presentation topic and language. In principle, the presentations will be in the same language as the published contribution. The official languages of the conference are Slovenian and English.
